

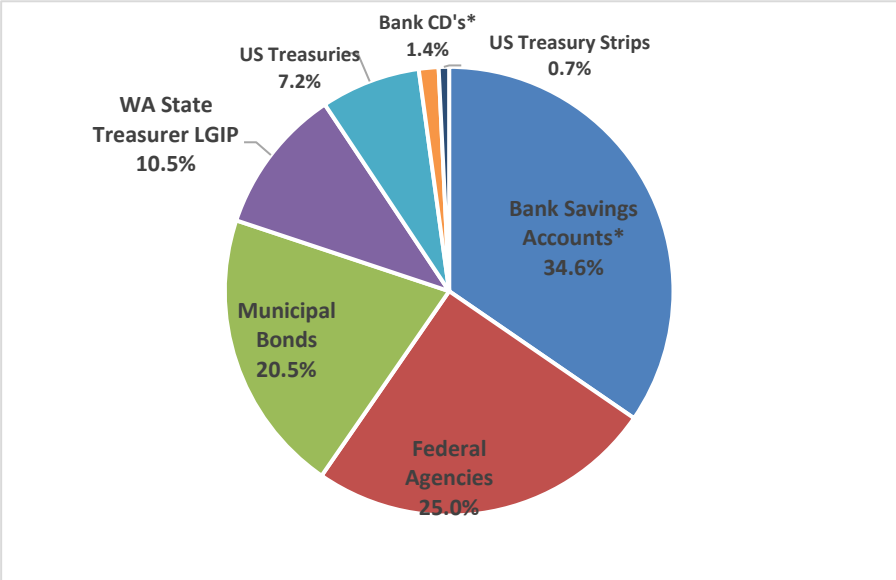

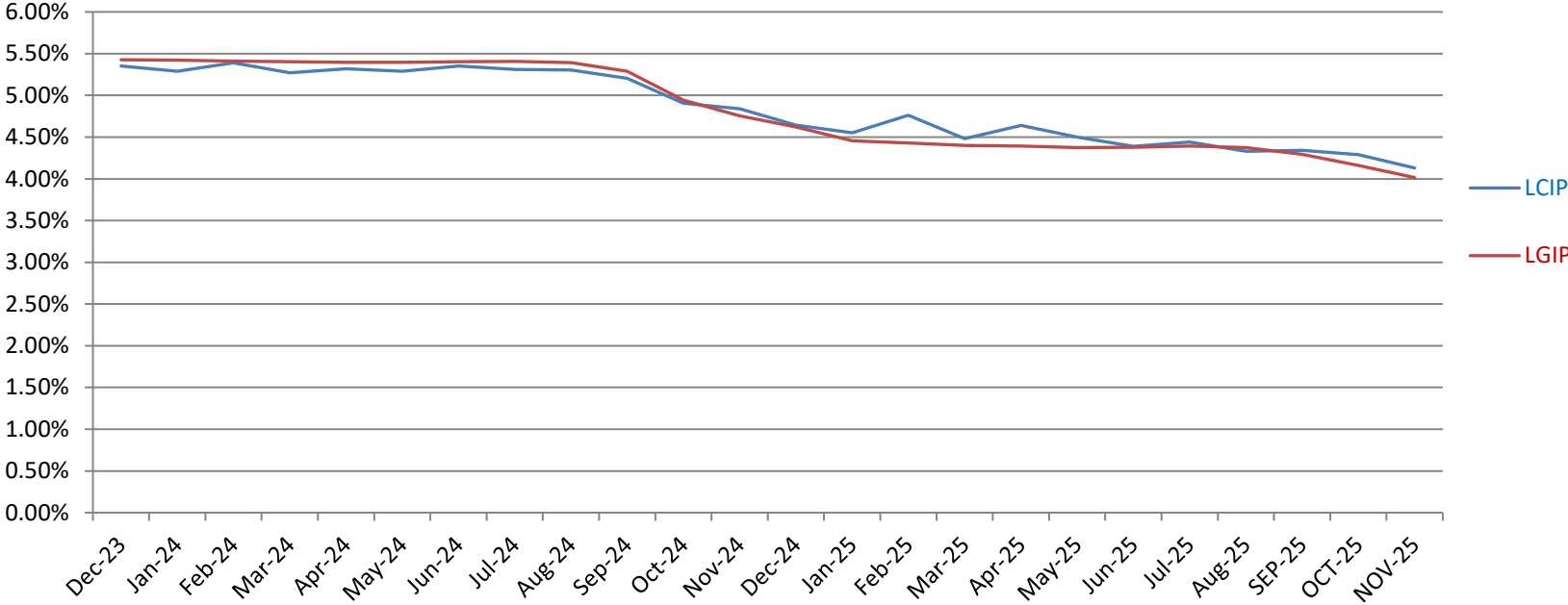

Rate of Return - Last 24 Months

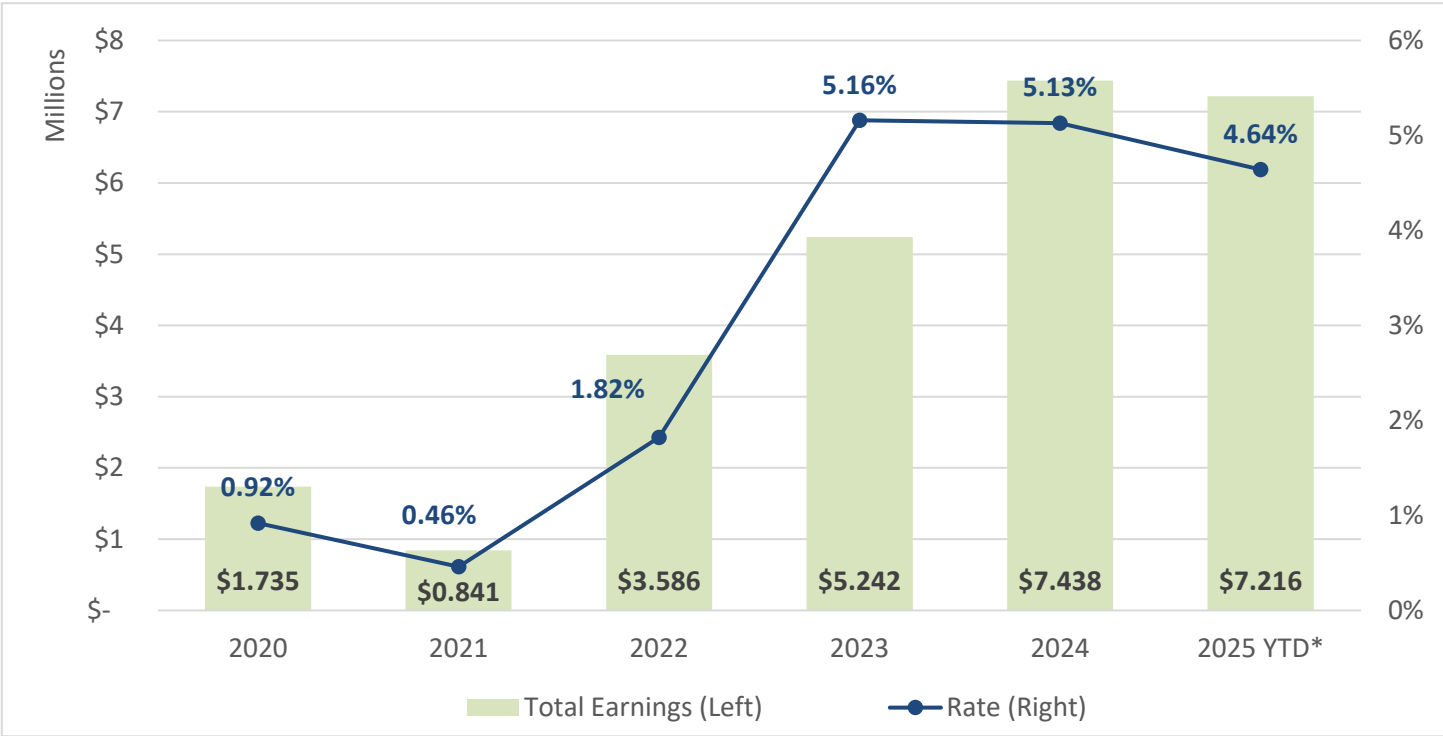

*2025 year-to-date through November 30

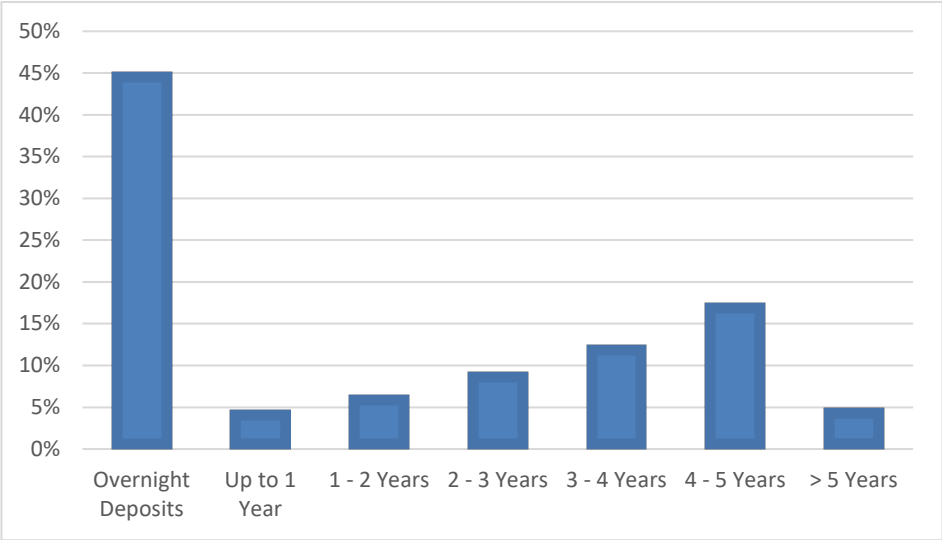

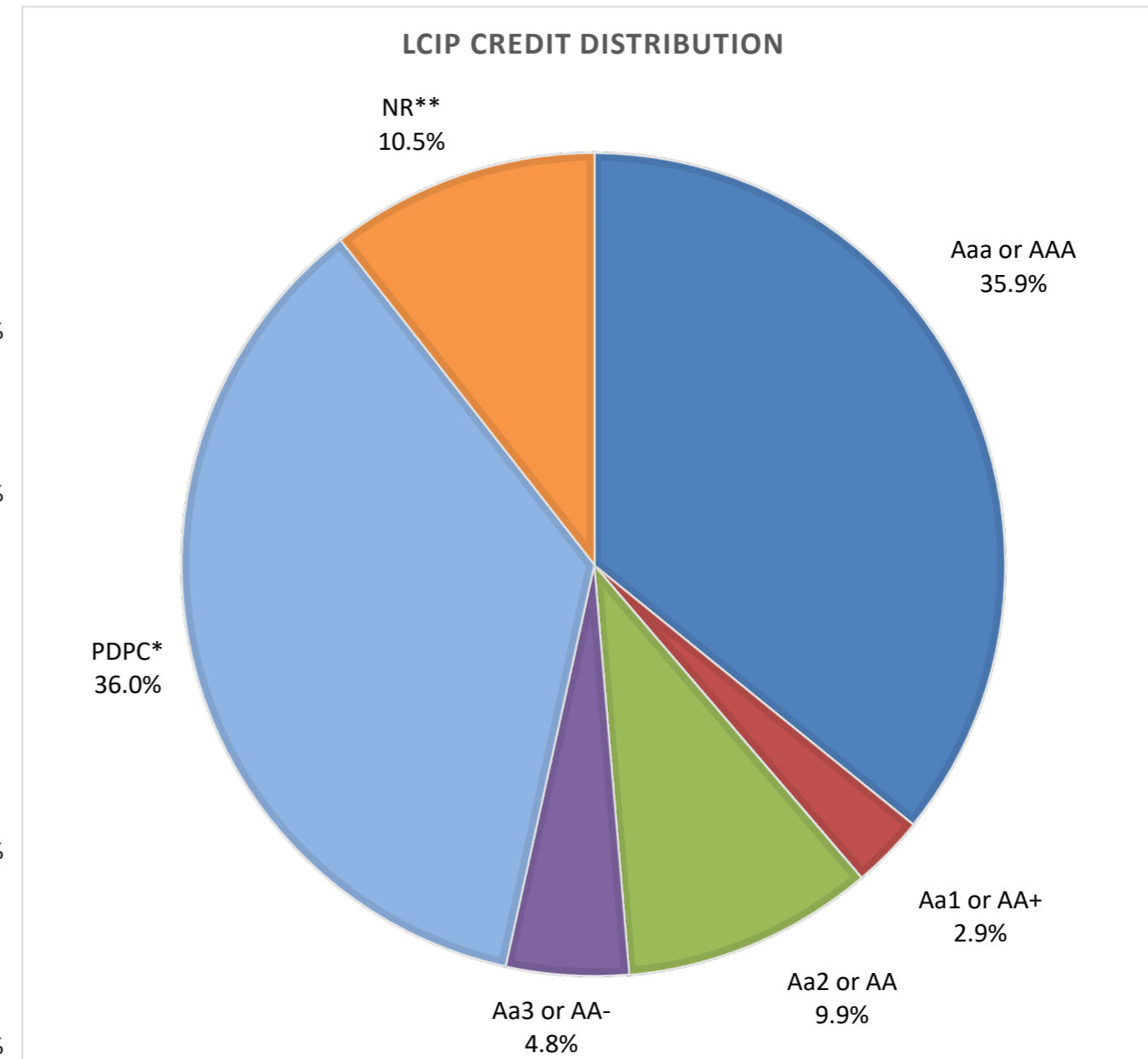
